OFFICIAL MEETING MINUTES

1. **Call to order and roll call:** Chairman Melcher called the meeting to order at 6:30 PM. Members present were Mark Melcher, Mark Levandowski, Katie Schroeder, and Mike Penkwitz.
2. **Approve agenda:** Motion was made by Schroeder/Penkwitz to approve the agenda. A unanimous aye vote was cast. Motion carried.
3. **Approval of October 23, 2023 minutes:** Motion was made by Penkwitz/Schroeder to approve the minutes for October 23, 2023. A unanimous aye vote was cast. Motion carried.
4. **Election of Chair and Vice Chair:** Levandowski nominated Melcher for Chair. Schroeder nominated Levandowski for Vice Chair. Motion was made by Schroeder/Penkwitz to elect Melcher for Chair and Levandowski for Vice Chair. A unanimous aye vote was cast. Motion carried.
5. **Audience Comment:** Josh Chapman from PYAA talked about the upgrades at Lions Park. He asked to work closer with the Park Committee and the City. He asked if the City could start cleaning the bathrooms and for some help mowing and painting lines.
6. **Discission and Recommendations on Nut Hill Ski Project:** Winter Park LLC presented what they would like to do for the future of Nut Hill. They would like to operate Nut Hill as a non-profit organization and make significant improvements to the infrastructure, facilities, and property to support tubing, skiing, snowboarding, and ice skating. They plan to raise capital funds to support snowmaking, grooming, building improvements, land modifications, and install a magic carpet. Melcher stated that it seems like an ambitious project, but doesn't see any problems. Penkwitz stated he is impressed with the dedication and asked if concerns of the water runoff has been addressed. Gentine answered that engineers are still working on catch basins and the group was addressing the concerns of the trees, along with the lighting, noise and the magic carpet location.
7. **Discission on Future City Park Projects:** Austin updated the committee on the future projects for City Park to have ADA bathrooms and potential updates to the skate park and playground.
8. **Golf Course Update:** Autin updated the committee on the driving range. It has been closed for the 2024 year. A quote for 100ft net is \$700,000. The committee gave some input and had questions on what to do with the area in the future.
9. **Communications – Letters, emails, or reports related to the Committee:** Schroeder mentioned the residents who play tennis are having a hard time getting any playing time on courts due to the courts being used by picklers. Schroeder suggested having tennis only courts.
10. **Adjourn:** Motion was made Levandowski/Penkwitz to adjourn the meeting. A unanimous

aye vote was cast. Motion carried.
